

SHEZ SHOW WORLD SUPERBIKE FANTASY CHAMPIONSHIP

CONSTITUTION - 2011

1. Descriptions

- Member A person who has registered at the club and allocated a membership number and a group
- Group A group consists of a number of people each of whom is allocated a rider for each round of the championship. Each group's numbers cannot exceed the listed riders for that championship (wildcards are not included but can be allocated). The maximum capacity for each group shall not exceed 50. There is no limit on the number of groups. Once each group is filled to capacity, a new group is then created.
- Permanent Rider A rider listed by a team at the beginning of the year as a team rider
- Wildcard A rider used by the team for less than the full year, normally only a round or two. This is also indicated on the site (www.worldsbk.com)

2. Objective

- 2.1. To create awareness for Sheridan Morais
- 2.2. To increase the profile of Sheridan Morais
- 2.3. To assist, where possible, the funding of Sheridan Morais' overseas riding campaign.
- 2.4. To create an environment for the enjoyment of the members who support Sheridan Morais, World Superbikes, World Supersports and Superstock 1000, to meet monthly and/or weekly for discussions, prizes and reports.
- 2.5. To ensure that all members get value for their subscriptions.
- 2.6. To ensure that all monies raised are expended appropriately as detailed herein.

3. Subscriptions

- 3.1. Subscriptions are paid in advance of each and every listed round of the World Superbike Championship, World Supersport Championship or Superstock Championship, whichever is elected at the beginning of each year.
- 3.2. Subscriptions are set for R150 (one hundred and fifty rand) per round per member of each group, for the championship(s) elected for 2012 (this payment shall include food provided, such substance shall be at the sole discretion of the committee).
All drinks will be for the account of the individual member.
- 3.3. This subscription may change from time to time
- 3.4. All members who register agree to ensure that this is paid without fail or deduction. Such subscriptions cannot be withheld for any reason.
- 3.5. All subscription payments will be allocated to the oldest outstanding amount.
- 3.6. Subscriptions can be paid, in advance, for the full year.
- 3.7. Any person who has failed to pay the required subscription for 3 (three) rounds will not be placed in the draw for the following round.
- 3.8. Any person who owes any portion of any subscriptions (or has any amounts outstanding) as at the final draw will be excluded from the results of that round.

- 3.9. No person who has any fees outstanding as at the final draw will not be eligible for a trophy or championship winnings. The next person in line will qualify for that placing, winnings and trophy and thereafter each member will move up a spot in the championship..
- 3.10. No person who has any fees outstanding will be invited to the year end prize giving ceremony.
- 3.11. It may be elected to have an extra meeting and draw at any time (ie a MotoGP race meeting), such draw results can be included into the then current championship.

4. Registration

- 4.1. Registration to the club is R250 (two hundred rand) per year, per group entered.
- 4.2. Such registration may not be withdrawn.

5. Rules

- 5.1. Each member will make every effort to attend the draw.

Draw

- 5.2.1. A draw will take place before each round of the championship elected.
- 5.2.2. At each draw, there will be a list of riders and also a listed of members from a group.
- 5.2.3. A draw of the member will take place, then a draw of a rider will take place.
- 5.2.4. The member will score the corresponding points of the rider which was drawn against his name.
- 5.2.5. Members are encouraged to join the club at each draw for drinks and food. This will foster good relations amongst all the members.
- 5.2.6. Once the first group is allocated riders, the next group will also be allocated riders as per the details above.
- 5.2.7. At a nominated round, it may be decided to auction a rider off for that round. In that case, the highest bidder will be allocated that rider for that round. In this case, the highest bidder may not bid in the following auction, thereby allowing other members to “win” a bid.

Groups

- 5.3.1. Each Group will have a results sheet
- 5.3.2. The group numbers cannot exceed the number of permanent riders listed in the championship (Wildcard cards can be included).
- 5.3.3. If a rider is injured during the year, a replacement rider can be used for those rounds the permanent rider is injured for. As such he is not a wildcard.
- 5.3.4. Where a permanent rider has been (for any reason whatsoever) not been included in the weekend’s race entry, a nominated wildcard will be chosen as the replacement for that round.
Due to the nature of the sport, and the fact that the meeting may take place before the entry list is finalised, the person responsible for the publishing of results will nominate (without favouritism or prejudice) a wildcard to replace the permanent rider not entered. This will be completed at the finalisation and publishing of the entry list on the WSBK website.

- 5.4. Results
- 5.4.1. Results per group will be published on the web page (www.emtekracing.co.za) as soon as possible after each round.
- 5.4.2. It is required of each member to check these results for accuracy within a reasonable time frame. Results cannot be changed after the next 2 rounds have been completed.
- 5.4.3. A member will get the points which are achieved by the rider(s) allocated to him at the last draw for each heat raced. There is only one winner on the day, calculated by totaling both heats against the rider.
- 5.4.4. Points are as follows:

- 5.5. Prizes
- 5.5.1. Prizes are awarded per group for the day results in 1st, 2nd and 3rd places.
- 5.5.2. Prizes are awarded as follows, per group per race:-
1st - R300; 2nd - R200; 3rd - R100
These prizes will not be paid out, but be allocated to the member for his subscriptions for the following rounds. At the end of the year, a full reconciliation will be completed and any excess funds will be reimbursed to the member.
- 5.5.3. Prize giving will take place at the next meeting following the weekends racing.

- 5.6. Champion
- 5.6.1. A **Shez Show WSBK Fantasy Champion** shall be crowned at the year end function for each group.
- 5.6.2. The champion shall receive a trophy and R6,000 cash
- 5.6.3. 2nd Place Shall receive a medal/trophy and R2,000 cash
- 5.6.4. 3rd Place Shall receive a medal/trophy and R1,000 cash
- The main trophies shall be floating trophies and are to be returned prior to the next year-end prize giving. Each winner shall also receive a trophy to keep.

6. Elimination, Exclusion or Expulsion

- 6.1. Any member shall be excluded from a round and/or removed from the fantasy championship if he is voted out by all members by means of a simple majority vote.
- 6.2. Such vote may be via email
- 6.3. This is to ensure the good relationship and standing of the club.
- 6.4. Any reason can be used to remove a member from the club if it is deemed necessary by the committee and then voted on by at least 75% of the existing members at that time by a simple majority.
- 6.5. Each member shall have 1 vote for each registration he/she has filled out.
- 6.6. The Chairperson shall have a casting vote in the case of a tie.
- 6.7. The exclusions detailed under subscriptions also apply here..

7. Year End

- 7.1. As soon as deemed necessary, after the final round of the elected championship, a gala dinner will be arranged for all members and their partner.
- 7.2. Food will be catered for by the club. Drinks will be for your own account.
- 7.3. At this function all winners will be announced and prizes handed out (See exclusions detailed under subscriptions).

- 8.1. The Committee (excluding the life Chairman) shall be elected at the beginning of each year at the first meeting of the club.

9. Spending the proceeds

- 9.1. The committee shall be allowed to utilize the unused proceeds to purchase memorabilia for the club members. This shall only be contemplated if each registered member gets an equal share of such memorabilia (ie. T-shirts; caps; watches, etc.)
- 9.2. As and when deemed appropriate, unused excess proceeds can be used to fund Sheridan Morais' overseas campaigning. This does need the full support of the committee and at least 25% of the members. This is one of the primary objectives of the club.

10. General

- 10.1. Please note, at all times each member is responsible for his own drinks.
- 10.2. At no time will the club be responsible for any debts whatsoever unless detailed in this constitution.
- 10.3. Each member is required to sign a copy of the constitution at registration.
